## **How Bradley Tax Consulting can help individuals moving to Ireland**

### ***Structuring of tax affairs***

This work is undertaken after taking account of all sources of income and gains e.g. employment income, share options, investment income, investment assets etc.

### ***Advanced planning for non-Irish domiciled individuals***

There is a special tax regime for non-Irish domiciled individuals, which requires advanced planning to ensure that Irish tax liabilities are not inadvertently triggered.

### ***Reliefs and relocation expenses***

We provide support with claiming various relocation expenses and reliefs (such as split year residence relief, special assignee relief programme, etc).

### ***Administration matters***

We determine if Irish or UK social insurance should be paid and the procedures to be adopted under either approach. We provide assistance with applications for Irish tax numbers, applications for certificates of tax credits, registration with the Irish tax authorities and filing of Irish tax returns.

### ***Payroll solutions***
